This is a full-time, SAFER Grant funded position that is responsible for the recruitment and retention of volunteer firefighters. The Volunteer Recruitment & Retention Coordinator reports directly to the Division Chief of Training. The position is funded for three years with no guarantee of employment after the grant period runs out. Anticipated start date: January 4<sup>th</sup>, 2021

#### About the District

The Umatilla County Fire District # 1 provides fire, rescue and medical services to over 37,000 citizens within the fire district boundaries and an additional 10,000 citizens in the balance of its ambulance service area. The Fire District serves the Cities of Hermiston, Stanfield, Umatilla and Echo and the surrounding area for a total of 600+ square miles which include the Umatilla Army Depot and part of Morrow County. The Fire District operates out of four fire stations with a fifth currently being built. Stations 21 and 22 are staffed 24/7/365 and station 23 and 24 are staffed with limited career staff and volunteers. Station 25, currently being constructed will be done in the fall of 2020 and will go through a volunteer recruitment process for its future staffing needs.

### **Ideal Candidate**

The ideal candidate will enhance the following qualities; accountability, excellence, integrity, and professionalism. The candidate will work in partnership with both, the community and the Fire District. In doing so, this individual should have a background in marketing, communication, or business. The candidate will value employees and volunteers of the organization and will strengthen an already strong program. The candidate will develop community service and volunteerism that supports a commitment to public service.
